

Making Tax Digital for Income Tax Self Assessment (MTD ITSA)



Making Tax Digital for Income Tax Self Assessment (**MTD ITSA**) is **HMRC's** (His Majesty's Revenue and Customs) next major step in **digitalising the UK tax system**.

From **April 2026**, **sole traders and landlords** with annual business or property income will **need to**:

- Keep **digital records** of income and expenses
- **Submit** quarterly updates and an End of Period Statement EOPS (annual report for business income) **through HMRC-recognised and approved software**
- File their **final declaration**, so annual report for personal income (replaces year-end self assessment) **via the same digital system**

MTD mandate is based on annual income thresholds:

Phases Business or property income threshold

April 2026

Above £50 000 in MTD scope



April 2027

Above £30 000 in MTD scope



April 2028

Above £20 000 in MTD scope



Challenges for sole traders related to MTD

- Adoption of new bookkeeping and processes
- Additional work with HMRC report submissions
- Added work, stress and pressure for individual entrepreneurs
- Penalties are increasing for late submission or non-compliance
- MTD isn't just a compliance change, it essentially reshapes the way sole traders lead their business
